### COMMISSIONER'S MEETING December 5, 2011

The Bartholomew County Commissioners met in regular session on December 5, 2011 in the Governmental Office Building, 440 Third Street, Columbus, Indiana. Chairman Carl Lienhoop called the meeting to order at 10:00 am. Commissioner Larry Kleinhenz, Commissioner Paul Franke, Auditor Barbara J. Hackman, and County Attorney J. Grant Tucker were also in attendance. Auditor's Office Department Supervisor Catherine Greenlee gave the Invocation and led the Pledge of Allegiance.

Next, the minutes of the November 28, 2011 meeting were approved unanimously on a motion by Commissioner Kleinhenz and seconded by Commissioner Franke.

The Voucher Claims were presented for approval. Commissioner Franke made a motion to approve the Voucher Claims. Commissioner Kleinhenz seconded the motion that passed unanimously.

Next, Chairman Lienhoop read the New Permits Report from 11/28/2011 to 12/2/2011. Sixty-five permits were issued with a fee amount of \$8,656.00 and a valuation amount of \$2,265,403.00. The total monthly fee amount for November 2011 was \$32,740.00.

Next, County Highway Engineer Danny Hollander presented the Commissioners with the Weekly Crew Report. Last week, the Highway Crew patched roads, mowed in Harrison and German Townships, put up signs, dug for a waterline at the Highway Garage, cut up trees, placed stone on school bus turnarounds, finished wedging in Wayne and Columbus Townships, and put sandboxes in the trucks.

The MS4 Operator Monthly Report was not ready for today's meeting, so it will be presented at a later Commissioners' meeting.

Next, County Attorney J. Grant Tucker began opening the year end bids. While the bids were opened, Chairman Lienhoop mentioned that Highway Superintendent Dwight Smith will be the 2012 President of the Highway Group for the State of Indiana.

Chairman Lienhoop said he received a book on the Courthouses of Indiana when he attended the State Commissioner's Conference last week. All three Commissioners mentioned that they (and passed Commissioners) have done a good job keeping up with the maintenance of the Bartholomew County Courthouse even though it costs a lot of money to keep it up compared to other counties.

Bartholomew County resident Mike Lovelace mentioned to the Commissioners that the Annex is not in good shape, and they need to look at constructing a new Annex building. Mr. Lovelace said that he understands that the Commissioners do not want to bond to build a new Annex because that could affect them getting re-elected. Commissioner Franke said that getting re-elected is not the reason that the Commissioners have not bonded in order to build a new Annex building, but the time is quickly approaching to replace the Annex building.

Mr. Lovelace suggested that the Commissioners build behind the current Annex building. Mr. Lovelace said he read on the Internet that the Commissioners might build a new Annex and new Highway Garage in one (1) complex. Commissioner Franke said the Commissioners are not sure if they will build two (2) separate facilities or build one (1) huge complex because this is still in the discussion stage.

Commissioner Kleinhenz asked why Mr. Lovelace suggests building a new Annex behind the current Annex building. Mr. Lovelace said that the building could be three (3) to four (4) stories tall, and then tear down the current building and make that the parking lot.

Commissioner Kleinhenz said that the Commissioners are trying to set aside money to build the new Annex and/or the Highway Garage. Chairman Lienhoop and Commissioner Kleinhenz said that the current Annex building has numerous problems, so they do not want to put in lots of money to fix these things if they are looking at building a new Annex.

Commissioner Kleinhenz said that the Commissioners are leasing space that costs the County between \$15,000 and \$16,000 a year. Therefore, the Commissioners are looking at moving the office that is in the leased space into the new building(s) to save the County money. Bartholomew County resident John Dishinger asked what space the Commissioners are leasing. Chairman Lienhoop said the leased space is for Soil and Water. Mr. Lovelace said if the Commissioners decide to purchase some land to build new structures, then they need to make sure they buy enough land so they will not become land locked. Chairman Lienhoop asked for feedback from the audience on how they would feel if the County and City consolidated into one (1) Highway Garage. Chairman Lienhoop said one (1) difference between the City and County is that the County uses a 3:1 salt to sand ratio; whereas, the City does not use that much sand because they do not want it to get into the sewers. Andy Mohr Truck Center employee Noble Jackson said that consolidation of the City and County will cause accounting issues. Likewise, each entity has different brands of vehicles and equipment, so more space will be needed for parts. Problems could also arise when determining how to bill the City mechanic for working on County vehicles, etc.
