## COMMISSIONERS' MEETING June 23, 2014

The Bartholomew County Commissioners met in regular session on June 23, 2014 in the Governmental Office Building, 440 Third Street, Columbus, Indiana. Chairman Carl Lienhoop called the meeting to order at 10:00 a.m. Commissioners Larry Kleinhenz and Rick Flohr, County Attorney J. Grant Tucker and County Auditor Barbara Hackman were also in attendance.

County Councilman Bill Lentz gave the Invocation and led the Pledge of Allegiance.

The first item on the agenda was the approval of the June 16, 2014 Meeting Minutes. Commissioner Kleinhenz made a motion to approve the minutes, seconded by Commissioner Flohr, and the motion passed unanimously.

Next was the approval of the payroll. Commissioner Flohr made a motion to approve the payroll, seconded by Commissioner Kleinhenz, and the motion passed unanimously.

The next item on the agenda was the weekly reports. Chairman Lienhoop read the New Permits Report dated 6/16/14 to 6/20/14. Twenty (20) permits had been issued with a fee amount of \$1,640.00 and an estimated construction cost of \$972,975.

County Engineer Danny Hollander requested the release of Driveway Bond 13B-003 located on 75S near 1025E. Commissioner Kleinhenz made a motion to release the driveway bond. Chairman Lienhoop seconded the motion that passed unanimously.

Engineer Hollander presented two (2) bids for wedging work received from Milestone Contractors, LP (Columbus) and Dave O'Mara Contractor, Inc. (North Vernon). (See attached) Commissioner Flohr made a motion to accept the low bid of \$103,877 from Milestone Contractors for wedging work. Commissioner Kleinhenz seconded the motion that passed unanimously.

Engineer Hollander then gave the County Highway Weekly Crew Report which included the following work: patched roads; mowed in Columbus, German, Clay, Wayne and Flatrock Townships and at the fairgrounds; replaced pipes on 600E, Legal Tender and Old Nashville Roads; extended the pipe on 265N; wedged in Wayne Township on 1100S and 60E; did chip and seal in Rockcreek Township on 300S, 600E, 400S and 750E; and hauled stone to the fairgrounds.

For the next agenda item Major Gary Myers from the Sheriff's Department presented three (3) quotes for an Insinkerator commercial garbage disposal:

Commissioner Kleinhenz made a motion to accept the low bid from South Central Company, Inc. for \$3,482.50. Commissioner Flohr seconded the motion that passed unanimously.

The Commissioners addressed the ratification of an expenditure for a Zoll AED Plus Defibrillator for the Bartholomew County Jail lobby. Northern Kentucky Emergency Medical Services quoted a price of \$1,320.00. Commissioner Kleinhenz made a motion to ratify the purchase of a Zoll AED Plus Defibrillator for the Sheriff's Department from NKEMS. Commissioner Flohr seconded the motion that passed unanimously.

Veterans Service Officer Tom Crawford read the Veteran's Services Report for the month of May, 2014. The Veteran's Office conducted 147 scheduled/walk-in/outside interviews, filed 72 claims and applications and 17 tax abatement forms, filed 21 power-of-attorney documents, attended 12 veterans meetings, made 18 trips to the VA Hospital and traveled 1,823 miles. Additional contacts totaled 282 by phone and 72 by mail. Commissioner Kleinhenz made a motion to accept the Monthly Veteran's Report for May, 2014. Commissioner Flohr seconded the motion that passed unanimously.

The Commissioners received a request from Harrison Lake Country Club to temporarily close Country Club Road on July 3, 2014 from 7:00 p.m. to 11:00 p.m. for fireworks display. Chairman Lienhoop made a motion to grant the request to close Country Club Road on July 3, 2014 from 7:00 p.m. to 11:00 p.m. Commissioner Flohr seconded the motion that passed unanimously.

There being no other business the meeting was adjourned by Chairman Lienhoop at 10:35 a.m. The next Commissioners' Meeting will be held on Monday, June 30, 2014 at 10:00 a.m. in the Commissioners' Chambers.
