

COMMISSIONERS' MEETING

June 6, 2016

The Bartholomew County Commissioners met in regular session on June 6, 2016 in the Governmental Office Building, 440 Third Street, Columbus, Indiana. Commissioners Rick Flohr, Larry Kleinhenz and Carl Lienhoop were present. County Attorney J. Grant Tucker and County Auditor Barbara Hackman were also in attendance.

Chairman Flohr called the meeting to order. Catherine Greenlee from the Auditor's Office gave the Invocation and led the Pledge of Allegiance.

The first item on the agenda was the approval of the May 31, 2016 Commissioners' Meeting Minutes. Commissioner Lienhoop made a motion to approve the minutes. Commissioner Kleinhenz seconded the motion that passed unanimously.

Next was the approval of payroll. Commissioner Kleinhenz motioned to approve the payroll. Commissioner Lienhoop seconded the motion which passed unanimously.

The next item was weekly reports. Chairman Flohr read the New Permit Report dated 5/30/16 to 6/3/16. Thirty-four (34) permits had been issued with fees collected of \$2,997 and estimated construction costs of \$1,461,426. Fees collected for May, 2016, totaled \$11,022.

County Engineer Danny Hollander gave the Highway Weekly Crew Report which included the following work: patched holes; bermed roads for overlay; replaced pipes on Base Road, 930S and Pond Drive; replaced driveway pipes on 550W and on Youthcamp Road; mowed in German and Rockcreek Townships; and graded and stoned the road behind Circle K in Taylorsville.
